**BA-21-252      Approval – Board Appointment to Fill Vacancy (President Humbles)**

**Action Item      Motion/2<sup>nd</sup>/Roll Call**

### **Pertinent Fact(s):**

1. Per Iowa Code, if a vacancy on a School Board occurs prior to the expiration of a term of office, the vacancy will be filled by Board appointment within 30 days of the vacancy and consistent with Iowa law. If the Board chooses to appoint, the Board Secretary shall post notice of the Board’s intent to fill the vacancy by appointment in a newspaper having general circulation in the District.
2. The notice must state that the electors of the school district have the right to file a petition within 14 days of the publication of the notice requiring that the vacancy be filled by special election. The Board may appoint to fill the vacancy after the notice is published or after the vacancy occurs, whichever is later. The newly appointed Board member will hold office until a successor is elected and qualified at the next scheduled school election.
3. The suggested motion is as follows:

“I move that the Board of Education approve the Appointment of Scot Reisinger to fill the vacancy on the Cedar Rapids Community School District Board of Education until the next School Election scheduled for November 2021.”

### **Recommendation:**

It is recommended that the Board of Education approve the Appointment of Scot Reisinger to fill the vacancy on the Cedar Rapids Community School District which will complete the term of Director Gary Anhalt and expire with the next School Board Election in November 2021.
