PUBLIC HEARING

BA-22-304 Public Hearing – Fiscal Year 2022-23 Budget (David Nicholson)

The Board of Education is required by State Code to publish a Fiscal Year 2023 Proposed Budget, hold a Public Hearing, and certify the budget and tax levy rates by April 15, 2022. Total District revenues are estimated at \$300,324,998 and total District expenditures are estimated at \$317,160,363. The District is proposing a published tax levy rate of 14.72968 per \$1,000 of taxable valuation, compared to the current rate of 15.71919 in FY2022. On March 28, 2022, the Board of Education approved publication of the proposed Fiscal Year 2023 District budget and scheduled a Public Hearing to be held on Monday April 11, 2022 to allow public comment regarding the FY23 District budget with a proposed total levy rate of 14.72968. The publication was scheduled to appear on April 1, 2022. However, due to a vendor system error, the budget did not get published as requested. As a result, the District was required to re-schedule the Public Hearing to April 14, 2022 in order to meet the 10-day minimum publication requirement.

If no objections are presented and sustained, the appropriate Board action is to give final approval to the Fiscal Year 2022-2023 Budget.
