INSTRUCTIONS TO VENDOR FOR COMPLETING PRODUCT SPECIFICATION SPREADSHEET (attachment B)

General Instructions

Decimals

The unit price offered may contain four points (0.0000) beyond the decimal and the extended price shall be rounded to the nearest whole cent. If the pack size bid for all distributors is not equal, a common unit will be determined and extension calculated based on common unit.

Drained weights

Drained weight of "wet pack: items shall conform to good industry practices and the minimum requirements of the Federal Food, Drug and Cosmetics Act. The individual products shall conform to drained weights as prescribed in the individual specifications of each product in 21 CFR. Except for whole tomatoes, drained weight is not a factor in USDA grades.

Fill of container

All products shall be filled as full as practical under good commercial packing practices without impairment of quality and in accord with the Federal Food, Drug, and Cosmetic Act regulations regarding individual specifications for standard fill (21 CFR).

Items not bid

If a vendor fails to offer a price on a line item, the highest value plus 5%, submitted from the remaining responsive bidders will be inserted for evaluation purposes.

If a vendor fails to accurately respond to bid specifications this item would be considered not bid, with the resulting action defined above.

All rows and columns within the Product Specification Spreadsheet must be completed to be considered complete.

Common Unit

For evaluation purposes, items will be converted to a common unit between all responses and extended for comparison. If a common unit cannot be determined, the EIPG reserves the right to omit the item from the evaluation process.

Product Specifications

Information that summarizes the characteristics of a product such as quality (Grade), size, weight, performance, storage information parameters, preparation, and safety requirements.

Nutrition Standards in Child Nutrition Programs and definitions:

Below are the requirements of SFAs to procure foods to be in compliance with the nutrition standards of Child Nutrition Programs:

TRANS-FAT - Food products and ingredients used must contain zero grams of trans fat per serving (less than 0.5 grams per serving). The trans fat restriction does not apply to naturally occuring trans fat in products such as beef and dairy products made with whole milk.

On commercially prepared products, SFAs must refer to the nutrition facts panel or the manufacturer's specifications to determine there are zero grams of trans fat per serving. A mixed product such as beef burrito that may contain both naturally occuring trans fat (e.g. beef) and added/synthetic trans fat (partially hydrogenated oil), the SFA must have documentation from the manufacturer the source of the trans fat and how much of trans fat is naturally occuring versus added trans fat.

WHOLE GRAIN-RICH - Child Nutrition Programs have whole-grain rich requirements. This means that at least 50 percent of the grain product must be whole grain meal and/or flour. The remaining 50 percent or less of grains, if any, must be enriched. Foods that are 100 percent whole grain meet the whole grain-rich criteria. Foods are not required to be 100 percent whole grain. Therefore, foods between 50 and 100 percent whole grains are allowable

SFAs can strategically utilize non whole-grain rich items in a limited capacity. Therefore the Product Specification Spreadsheet includes a variety of both whole-grain rich items and non whole grain rich items.

CREDITABLE GRAINS - Whole meal, whole flour, enriched meal, enriched flour (and/or bran or germ for CACFP, SFSP and afterschool snacks only)

SODIUM - Sodium amounts are closely monitored. Low sodium and reduced sodium items will be specified within the Product Specification Spreadsheet.

COMPLIANCE WITH BUY AMERICAN PROVISION - All SFAs participating in the NSLP and SBP are required to purchase, to the maximum extent practicable, domestic commodity or product.

CHILD NUTRITION (CN) LABELS - The CN Labels are a regulated form of documentation that provides a way for the food manufacturers to communicate with SFAs about how their products contribute to the meal pattern requirements for meals served under the Child Nutrition Programs (CNP). SFAs and manufacturers can click on the link https://www.fns.usda.gov/sites/default/files/cn/cnl_tipsheet-processedproduct.pdf to review the TIP Sheet for Accepting Processed Product Documentation.

PRODUCT FORMULATION STATEMENT (PFS) - The PFS are a regulated form of documentation that provides a way for the food manufacturers to communicate with SFAs about how their products contribute to the meal pattern requirements for meals served under the Child Nutrition Programs (CNP).

- PFS Must Include:
 - Signed company letterhead. (signature on PFS can be handwritten, stamped, or electronic.
 - Product name, product code number, and serving/portion size
 - Demonstrates how the food item contributes towards the meal pattern requirement (i.e. provides information to calculate crediting) with supporting documentation as needed.
 - Additional product information may be requested for verification.

Column 1 – Item Number – protected cells, used as reference

Column 2 – Item Specification/Product Description – protected Cells

- a. When a particular manufacturer's name and product number and the phrase "or equal" appear in the description, any manufacturer or brand will be considered as long as the performance and quality levels are equal to the product specified. The bidder shall supply sufficient data to enable a comparison to be made with the particular product specified. (A product sample may be requested by the EIPG administrators.)
- b. When Distributor's Choice is indicated in the description, the vendor may offer a price on any brand that meets the desired quality levels. The brand on which the price is offered must be stated in Column 3 and cannot be changed during the effective period without the permission of the school district

c. Product specific dispensers, for items such as but not limited to napkins and condiments, shall be provided free of charge for the required number of dispensers with first delivery in the first year and as needed in subsequent years of contract.

Column 3 – Brand Bid

Column 5 – **Distributor Product Code**

Indicate Distributor Product Code for the item bid.

Column 6 – Pack Size

Indicate pack size of item bid. Group A only – indicate # of servings per case in addition to pack size.

For bulk catch weight items, list price per pound.

Column 7 – Cost to Distributor

Enter the distributor's invoice cost from the manufacturer, including freight.

Column 8 – Allowance

Enter the amount of allowance, rebate, discount or billback that will offset the price to the districts.

Column 9 – Allowance Expiration Date

List date when allowance in Column 8 expires.

Column 10 – Fixed Fee

List fixed fee per case – must be a monetary value. Cost plus percentage method is prohibited by Federal regulation. Fixed fee shall be firm for the duration of the contract.

Column 11 – Final Unit Price to District – protected cells, formula will calculate

Cost to Distributor – Allowance + Fixed Fee = Final Unit Price

Column 12 – Firm Thru Date

All prices given are to be firm through 11/30/23 except group F, which is to be priced as of the week of January 9-13th, 2023. Indicate firm dates for any product beyond 11/30/23 in this column.

It is desired that prices for the goods listed in Attachment B shall remain unchanged for 12 months following the effective date of the contract. (exceptions granted for seasonal items June – October such as plums, nectarine, and peaches)

Column 13 – Combined Annual Usage

All volume estimates provided in this RFP are based on historical usage data of SFA. While good faith efforts are made in providing the quantities listed in this RFP, quantities are for estimation and planning purposes only. The accuracy of the product volume estimates may be affected by a number of factors including but not limited to availability of Federal funds and other subsidies, availability of USDA Foods, student preferences, budgetary constraints, and product prices, changing market conditions, product unavailability due to manufacturer discontinuance, or unintentional errors or omissions. The listed quantities are subject to change, with no guaranteed minimum order implied by this RFP.

Column 14 – Extended Price to District – protected cells, formula will calculate




