Board Secretary Rydstrom,

Please consider this as a formal written objection to the nomination of Kaitlin Byers as a candidate for Cedar Rapids Community School District Board of Directors, District 4.

The candidate's nomination petitions are insufficient for the following reasons:

- 1. They fail to meet the requirements of lowa Code 45.5.1d, that nomination petitions "...shall be in substantially the form prescribed by the state commissioner of elections." And provide a space for "The office sought by the candidate, including the district number, if any." Failing to include the office sought in the space provided on the form prescribed by the state commissioner of elections invalidates the signatures by 45.5.2 "Signatures on a petition page shall be counted only if the information required in subsection 1 is written or printed at the top of the page." This deficiency exists in each of the six pages on the candidate's nomination petitions, as evidenced in Exhibit 1.
- 2. The inclusion of "CRSD DISTRICT 4" as evidenced by Exhibit 1, appears to have been added after the fact in an obviously different handwriting, that of Craig Byers, the candidate's spouse as evidenced by Exhibit 2 comparing Mr. Byers signature on the nomination petition directly to the added language. On five of the six nomination petitions, the included language "CRSD DISTRICT 4" is located outside of the prescribed "Candidate Information" box entirely. On five of the six nomination petitions, the included language is in an obviously different handwriting. On all six nomination petitions, the included language is either outside of the "Candidate Information" box entirely or in an obviously different handwriting. There is also no evidence the added language was present on the paper at the time of signing. These deficiencies make the inclusion of "CRSD DISTRICT 4" insufficient to correct the failure to include the office sought on the prescribed form.
- 3. The inclusion of "CRSD DISTRICT 4" fails to accurately include the office sought by the candidate for Cedar Rapids Community School District Board of Directors, District 4. There is no provision in Iowa Code 45.5 for the use of initials of the school district in place of the legal name of the district. Further, "CRSD" is not commonly used to refer to the Cedar Rapids Community School District. The district itself does not use "CRSD" to refer to the district either. "CRSD DISTRICT 4" is not a sufficient description of the office sought to correct the failure to include the required information in 45.5.1d.

For these reasons, the six pages of nomination petitions for the candidate should be disqualified, and the nomination papers as a whole should be found insufficient to qualify the candidate.

Please accept this document as a formal written objection to the nomination of Kaitlin Marie Byers, as a candidate for the Cedar Rapids Community School District Board of Directors, District 4. Considering the many alterations appeared to have been made on each document, submitted by Kaitlin Marie Byers, this objection is being brought forth in the spirit of fairness, and the fact every candidate and their corresponding paperwork should be treated equally.

The following assertion is based on a first-hand account witnessed between The Secretary and Mr. Craig Byers during the morning of Thursday, September 21, 2023. In reviewing Kaitlin Byers candidacy paperwork, it is extremely difficult not to notice alterations made to both the affidavit and the nomination petitions. The questionable areas, in comparison to my own rejected forms, are as follows:

This objection also has legal ramifications as noted in lowa Code 45.5.1d, as well as the resource provided by the lowa Secretary of State School Board Candidate Guidance Book, also referred to by the Linn County Auditor's office. The appropriate sections of the Secretary of State Candidate Book have been attached to this formal objection, copies of Kaitlin Marie Byers paperwork, as well as my own [rejected] paperwork - rejected by The Secretary on Tuesday, September 19, 2023. A final note had I not started over in collecting petition signatures, after mine were initially rejected, I would not be a candidate for CRCSD, Director District 1. As opposed to Kaitlin Marie Byers petitions, given the dates, it is obvious that new signatures were not gathered after her original paperwork was initially rejected.

The candidate's party affiliation should be left blank.

Nomination Petitions

Candidates must collect signatures on nomination petitions and file the petitions at the same time the affidavit of candidacy is filed.

The nomination petition form for community college candidates is available on the Secretary of State's website: http://sos.iowa.gov/elections/pdf/candidates/ccnompet.pdf.

Candidate Information

Before anyone signs the petition, the required information in the candidate header of every petition page must be completed.

Best Practice: Complete the candidate header on one petition page and make copies of that page so all petition page candidate headings are identical.

The information listed below must appear on each petition candidate header. Signatures cannot be counted on petition pages missing the following information:

Candidate's Name

The candidate's name should be printed exactly as the candidate wishes the name to appear on the ballot. No parentheses, quotation marks, or titles (e.g. Dr., Mrs., etc.) may be included.

- Office Sought
- School District/Community College and Director District (if any)

The candidate must provide the director district number when running for a director district seat. Signatures on petition pages that do not provide the applicable director district number (when required) cannot be counted.

Type and Date of Election

The 2023 Regular City-School Election will be held on Tuesday, November 7.

Signers' and Candidate's Affirmation of Residence

The following statement must appear on each petition page:

"We, the undersigned eligible electors of the appropriate county, city, school district, school or community college director district, or other district as established by law,

Review affidavit and nomination petition headers. Nothing can be added to a notarized affidavit or a petition header if there are signatures on the page. Nomination papers can be returned only if they have been rejected. Count the signatures. Best Practice: File more than the required number of signatures since it is possible for signatures to be challenged. If there are signatures on a petition that should not be included, simply draw a line through the names. Those signatures will not be counted. Make a copy of nomination papers for own records. Bind nomination papers together. Nomination papers may be rejected without examination if not bound together.

File as early as possible.

Nomination papers will be inspected for completeness before they are accepted for filing. If nomination papers are filed early, candidates may have time to correct any

Nomination papers may be filed in person or by mail. When filing by mail, postmark dates are irrelevant. The school secretary must receive the papers by 5:00 p.m. on the filing deadline. If candidates would like to be contacted when their nomination papers have been received, they should indicate that when they mail their papers and include a daytime phone number at which they can be reached.

Important Note: It is the responsibility of the candidate to ensure the nomination papers are received by the school secretary before the deadline.
