This notice responds to the questions received by the Cedar Rapids Community School District regarding the above bid request.

QUESTION 1a	Your electronic file limit is 10MB. May we submit our response via a ZIP file?

QUESTION 2	Schools let out 6/4 or 6/5. We have seen in the RFP that your anticipated start date for summer programs is 6/11. Families do want child care for the week of 6/5 - 6/11 and we are prepared to operate. Would this be possible?
ANSWER 2	The last student day is Friday, June 7th. The first day of the program will be Tuesday, June 11th.

QUESTION 3	With low enrollment, what is your vision for the middle school programs?	
ANSWER 3	We would like to offer at least a MS option in each area, if at all possible.	

QUESTION 4	Can you provide enrollment numbers for the before and after school programs?
ANSWER 4	We do not have the current provider's service data. We have provided the enrollment student data for the buildings.

QUESTION 5	In regards to the section on Page 5 "Utilize the CRCSD food services for meals", does CRCSD want vendors to cover the cost of meals with our proposal or only require vendors to distribute meals to students?
ANSWER 5	Vendors will pay CRCSD for the meals.

QUESTION 6	Do you have desired locations for the upcoming 2024 Summer Camp already identified by CRCSD?
ANSWER 6	Locations are not known at this time but we will discuss with the vendor who is awarded the RFP.

QUESTION 7	Regarding utilizing CRCSD food service for meals, what is the CRCSD food service's capacity to provide meals to sites on days where the contractor will offer all day care (i.e. professional learning days) and is pricing available for this utilization of the CRCSD food service program?		
ANSWER 7	There is adequate capacity. Cedar Rapids Community School District currently utilizes these rates. (See image below)
